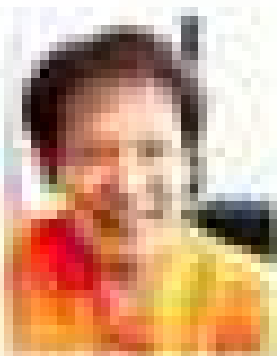

Abstract: The purpose of this study was to determine the effect of a 12-week training program on the physical fitness and health-related quality of life (HRQL) of sedentary, middle-aged women. The study was a randomized, controlled trial. The intervention group (n = 20) participated in a 12-week training program consisting of three sessions per week. The control group (n = 20) remained sedentary. The primary outcome was the change in HRQL, measured using the EuroQol-5D questionnaire. Secondary outcomes included changes in physical fitness, measured using a 6-minute walk test and a 10-minute step test. The results showed that the intervention group had a significant improvement in HRQL compared to the control group. The improvement was most pronounced in the physical domain, but also in the mental domain. The results also showed that the intervention group had a significant improvement in physical fitness, measured using the 6-minute walk test and the 10-minute step test. The results suggest that a 12-week training program can improve the physical fitness and HRQL of sedentary, middle-aged women.
